

The regular meeting of the Board of Health was held on Tuesday, May 23, 2017. Neil D. Paquette, Chairman; Timothy J. Fontaine, Secretary; and Elinor Kelliher, M.D., Member were present with Office Assistant Carolyn Rogowski recording the minutes. The meeting was called to order at 6:00 p.m. by Mr. Paquette.

Payroll schedules and bills were signed as approved by Board members. Minutes of the May 9, 2017 meeting was read by Board members. Motion made by Dr. Kelliher to accept the May 9<sup>th</sup> minutes as written, with Mr. Fontaine seconding the motion. All in favor 3-0.

Complaint received by email regarding chickens and other livestock at 14 and 35 Watson Lane. Mr. Paquette will investigate.

Brenda Shield-Dean from 95 Coolidge Avenue came in to meet with the Board to submit her floor plan for her business "Rusted Roots Apothecary & Market" which will be located at 65 East Street. She will be selling herbs, spices, and health & beauty essentials. All herbs will be in decanter and she will be purchasing them from a wholesale company located in Oregon. She will be providing knowledgeable flyers with all items she is selling. Board members inform her that she must be Certified in Food Safety and Allergen. Ms. Dean is planning on opening her business in July or August.

Inspection report submitted by Health Inspector Timothy Mendes due to a complaint made of 250/252 Winsor Street was reviewed by Board members. Mr. Fontaine excused himself from this discussion. Inspection report shows that there are old grape vines cut down and the complainant says that the rats are coming from underneath the vines. Certified letter will be written to the owner of the property ordering him to remove all debris within ten (10) business days of receipt of this letter.

Inspection report submitted by Health Inspector Andrew DaCruz due to a complaint made of Harmony Springs which is located at 136 Yale Street was reviewed by Board members. Inspection report shows that there is a lot of debris on the property, including a metal shelf completely abutting the neighbor's property of 134 Yale Street, as well as a truck blocking any egress in case of an emergency. Certified letter will be written to the owner of the property ordering him to remove all debris within ten (10) business days of receipt of this letter.
