

The regular meeting of the Board of Health was held on Tuesday, June 18, 2019. Carolyn Rogowski, Chairman, Adrienne DeSantis, Secretary, and Michael LaFever, Member were present with Office Assistant Tim Fontaine recording the minutes. The meeting was called to order at 4:00 p.m. by Ms. Rogowski.

Cheryl Messer-Lusty, Director of Nurses, came in to meet with the Board. Ms. Messer provided the following updates:

- There will be a Volunteer meeting being held on June 26, 2019 from 6:00p.m.-8:00p.m. A representative from N.E.T.A will be attending. They will be providing information on CBD oil and Cannabis.
- There will be a Nurses in-service training on July 30, 2019. A representative from N.E.T.A. will be attending from 1:00p.m.-3:00p.m. They will be providing information on CBD oil and Cannabis. A representative from Safeharbor will be attending from 3:00p.m.-4:00p.m. to provide information on the services they provide.
- There is a National shortage on Aplisol. It is a derivative in tuberculin which is used for TB testing. Our office uses Tubersol. As of right now there is no shortage on Tubersol. The CDC state that the shortage could continue for 3 to 10 months. Ms. Messer will monitor further to make sure we have enough supply of Tubersol for our residents.
- A TB Meningitis conference will take place on Friday June 21, 2019, 12:00 to 2:00 at Baystate Hospital Conference Room. Dr. Liautaud is requesting that all Public Health TB nurses attend. Board Members approve of Ms. Messer attending this conference.
- A HHAN drill, severe, was called at 1:00 p.m. on June 13, 2019. Our office completed the drill by the end of the day to meet the objectives.
- There will be a National Night Out held on Tuesday August 6, 2019. The Town is asking for participation from our office.
- The application to become a CERT Team has been approved by FEMA. The next step is for Ms. Messer to attend a "Train the Trainer" class.

Ms. Messer asked the Board about placing "No Tipping" signs in the pedicure area, along with mailing letters to our patients. Board Members are not fond of the idea and will table this discussion to the next meeting on July 2, 2019.

There was a Memo e-mailed to the staff from Ms. Messer on Friday, June 7, 2019. It was in regards to procedures not being followed properly. The Board wishes that the memo came to the Board first for approval. Ms. Messer provided copies of the Director of Nurses job description to the Board. It states that the Director is in charge of the daily operations for the nursing staff. Motion made by Ms. DeSantis to allow Ms. Messer to continue to have authority to communicate and oversee the daily operations of the nursing staff and to use the Board as advisors. Seconded by Mr. LaFever. All in favor 3-0.

Septic Inspector Michael Pietras was due to join the meeting at 4:30 p.m. to discuss a Variance request. There is also an enforcement letter that he would like the Board to sign. Unfortunately, Mr. Pietras was called out of the meeting before he could speak to the Board.

There was a request for a Variance for 298 Tower Road, owned by Mr. Dennis Fernandes. Engineer Lori McCool is asking for setback reductions due to lot size restrictions. The Variance was reviewed and approved by Board members.

Mr. Pietras is asking the Board to sign an enforcement letter to be sent to the homeowners at 75 Main Blvd. The septic system at this property is failing and needs to be replaced immediately. Board members approved and signed the enforcement letter.

Board members perused the minutes of the June 4, 2019 meeting. Motion made by Ms. DeSantis to approve the minutes as written, seconded by Mr. LaFever. All in favor 3-0. Minutes were signed by Ms. DeSantis.

Payroll schedules and bills were signed by all Board Members.

Board Members signed letters of extension for Septic Inspectors Mike Pietras and John Kopinsky.

The owners of EZ Shop Convenience and Chapin East Variety came to renew their Tobacco and Milk Licenses. These licenses expired on May 31, 2019. Any licenses renewed after the expiration date is subject to a 50% late fee. The owners are asking to have this fee waived. These businesses are consistently late with applying for the licenses. Board Members feel that because the businesses are habitually late, they are not entitled to a waiver of the late fees. Motion made by Ms. DeSantis to allow EZ Shop Convenience and Chapin East Variety one week to renew the permits. If not renewed, the Board will go and have all tobacco removed until the permits are renewed. Seconded by Mr. LaFever. All in favor 3-0.

A complaint was received regarding questionable business practices at Sewall Street Auto Center and Dan's Small Engine Repair. Board Members do not see anything in the complaint that would pertain to this department. No further action will be taken.

A complaint was received regarding trees being cleared at 201 West Ave. by The Nunes Companies Inc. Residents surrounding the area are concerned for their land. Board Members reviewed the request, but found nothing that pertains to this department. No further action will be taken.

A complaint was received regarding an unkempt property at 144 Richmond Road. Mr. Fontaine conducted an inspection and found that the property is not overgrown and neat in appearance. No further action is required by the Board.

A complaint was received regarding chickens and roosters at 18 Ampere Ave. Mr. Fontaine conducted an inspection of the property and found numerous birds in the back yard. There was a slight odor present at that time. A Certified letter will be sent to the homeowners requesting them to meet with the Board on July 2, 2019 at 4:00 p.m.

Reorganization of the Zoning Board of Appeals was reviewed by the Board.

A letter from Omni Environmental Group, Release Notification Form, for 71 Fairway Drive was reviewed by the Board.


