Health Agent Report

Mr. LaFever inquired about any inspections. Ms. Crete has been doing plan reviews. There have been no food inspections for this month. She will be focusing on the medium inspections next month. The COVID-19 pandemic has slowed down the amount of inspections.

Animal Inspector Sheila Andre has submitted her resignation. She has been with the department for 18 years.

Mr. LaFever feels we should fill the position of Animal Inspector. Ms. Crete is currently the backup inspector. Inquiries were made as to how much time is involved. Ms. Crete stated there are less than 50 barn inspections in Ludlow. Ms. Crete mentioned about herself doing the inspections for 1 year. The main requirement for the position is general knowledge of animals. There is no real training. Ms. Crete will inquire with the Animal Control Officer about possibly fulfilling the position.

Ms. DeSantis asked what institutes a barn inspection. Ms. Crete answered anyone that houses farm animals including chickens. There is a barn book that is filled out at the time of inspection. It mainly lists the owners, the number of animals, and if they look healthy. This barn book is confidential and once completed it is turned into the Department of Agriculture. They then use the information in case of a breakout or quarantine.

Ms. Crete provided an update on the COVID-19 vaccine clinic. The town did apply for vaccine. The department went through the required training. The State then decided that it will no longer allocate vaccine to individual sites. Ludlow is currently involved with a regional site in Palmer.

Ms. Crete gave an update on the Public Health Coordinator position. Martha Seed started her position on Monday, February 22, 2021. She is currently taking numerous online trainings to become familiar with the job. Ms. Seed will be introduced formally at an upcoming meeting.


