**New Business:**

Moved by Mr. Goncalves, seconded by Mr. Rosenblum to approve and sign all ten (10) copies of the Call of Election to be held on November 3, 2020. Vote 4-0. All in favor.

Board to discuss the old Senior Center Building and Ludlow Housing Authority concerning closing the building.

Ms. Villano explained that the new Senior Center is getting closer to opening. The Town has a 99-year lease with the Ludlow Housing Authority for the old Senior Center. The Ludlow Housing Director would like to meet and discuss what steps need to be taken. This building is owned by the State and the State will need to be informed that the Senior Center will be vacating that building. The boiler system is housed in the Senior Center that feeds the two buildings, the Admin Building and the Early Childhood and arrangements will need to be made if they're going to take over the heating.

Mr. Silva stated that a meeting with the Ludlow Housing Authority should be put together soon.

Ms. Villano explained that this building cannot be sold because it is not owned by the Town, it is only a lease. The lease was signed in 1984 and it is a 99-year lease, but it has no monetary value to it. A meeting with the Ludlow Housing Authority will be scheduled.

Moved by Mr. Goncalves, seconded by Mr. DeBarge to sign the copies of the agreement between the Ludlow Fire Department and Marcotte Ford for the purchase of the vehicle described here. Vote 4-0. All in favor.

The Board has received four letters of interest from residents to serve on the Pond Management Committee. Does the Board wish to schedule interviews?

The Board tabled this discussion until the next meeting.

Board to review and comment on the draft pilot program for Huxley Solar, LLC.

Mr. Goncalves commented that this will be approximately \$1.2-1.3 million in payments over the next 20 years, \$61,000 annually. This one is 20 equal installments as compared to the other one, which was front loaded. Mr. Goncalves would like to know if the Assessor's office already agreed with this? Mr. Goncalves also commented that he prefers the front loaded because we can't predict how much money



will be worth in the future and with everything going on right now it would be nice for the Town to have some additional money up front.

Mr. DeBarge thought that this draft was better than the front loaded one.

Mr. Silva explained that he likes the same payment every year because it makes it much easier for the Accountant and the Assessors, etc. Agawam just signed for \$15,000 per megawatt with a 1.5 escalator per year. There have been much higher contracts that he has seen. Even though we don't know the value of money in the future, taxes will move up and if you are declining then the tax payers will be responsible. \$11,000 to \$15,000 is average.

Ms. Villano stated that Mr. Silva will be involved with the negotiations.

Mr. Goncalves stated that the Town will have to manage the money better. There is a deal in Halifax, MA for \$11,800.

#### **Miscellaneous**

Mr. Silva read a resignation letter from Cheryl Messer, nurse from the Board of Health. Ms. Messer is resigning as of October 20, 2020.

Mr. Silva stated that Ms. Messer will be missed, and she did a great job during COVID and wishes her well.

Mr. Goncalves commented that Ms. Messer will be missed and spoke about how she was the face of the Board of Health and she was part of the frontline with the Police and Fire Department. Mr. Goncalves wishes her well.

Mr. Rosenblum thanked Ms. Messer for her time as well and also stated that she did a great job and wished her well in her endeavors.

Mr. DeBarge also thanked Ms. Messer for her service and stated that she will be missed, and the Town will feel a loss from this. Wishes her the best in the future.

#### **Closing Comments:**

Mr. DeBarge advised Veterans that on November 10<sup>th</sup> there will be a free Veterans meatloaf dinner at the Ludlow Lodge of the Elks at 69 Chapin Street, Ludlow from 4 p.m. to 6 p.m. and is being sponsored by PV Financial. Mr. DeBarge stated on November 11<sup>th</sup> at 11 a.m. there will be a Veteran's ceremony at the Gazebo. Everyone who endured damage from the storm on Wednesday, our thoughts go out to you. He knew of several residents who have had trees fall on their house, their cars and have had to go through a lot to clear their lots. The DPW workers were out cleaning up some of the streets in Town. Island Pond Cemetery has a lot of damage, trees down and stones damaged.


Mr. Goncalves stated along the same lines as Mr. DeBarge around 5 o'clock he lost power and heard a loud explosion, so he took a ride and could not believe how many trees were down. Mr. Goncalves gave kudos to the DPW for all their hard work. Mr. Goncalves reminded residents that the scams are getting

more and more creative. Police reports were filed today because of homes that Mr. Goncalves knows that are on Facebook for rent, complete with emails, pictures and stated the scammers are going in and requesting a small amount of money to hold the home and then tells the person a potential date to meet to pick up the keys. Mr. Goncalves stated there has been a rash of automotive break-ins in Ludlow as well. Mr. Goncalves advised residents to lock their doors at night because unlocked cars are being ransacked. Mr. Goncalves also asked if any residents have cameras and see something, to please report it to the police.

Mr. Rosenblum echoed Mr. Goncalves to always lock your vehicles and take any valuables inside. Mr. Rosenblum reminded residents if you are a little fearful of Halloween and the pandemic, please keep your light off. If you feel comfortable with it, then leave your light on or maybe put a table at the end of your driveway with individual bags or be creative with a PVC pipe shooting from the steps. Mr. Rosenblum advised all to adhere to the guidelines from the CDC and the State. Mr. Rosenblum stated we like to leave it up to the residents whether they participate or not and said it should not be up to the Selectmen to cancel Halloween.

Mr. Silva also echoes Mr. Rosenblum’s comments about Halloween. He understands even though he received some calls from residents that wanted it shut down, the Selectmen should not shut down something that some people don’t want to participate in and others do. Mr. Silva stated hopefully people will take the suggestions from the Governor and the CDC and take the necessary precautions. Mr. Silva stated as the weather gets colder, more people will be staying inside but the State has seen an uptick in COVID cases recently.

Moved by Mr. Goncalves, seconded by Mr. DeBarge to enter into Executive Session and not to return to this meeting at 7:12 p.m. and then adjourn from there for the purposes of discussing strategy and negotiations for L.A.T.O.S.S. union contracts. Vote 4-0 all in favor.
