Board to discuss transferring the budget for the Animal Control Officer to the Ludlow Police Department.

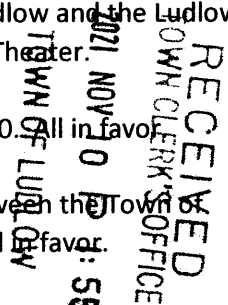

**CLOSING COMMENTS**

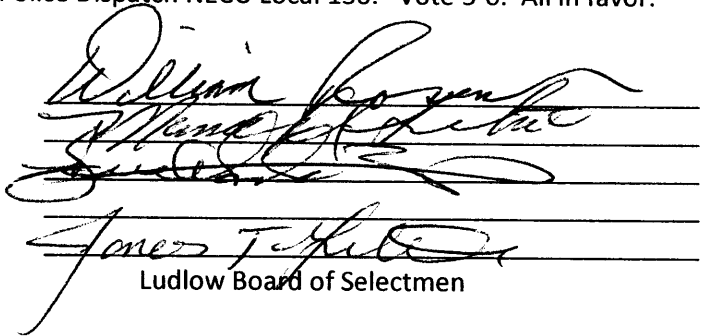
