**6:00 p.m. – Joint meeting with the Planning Board to discuss Joshua Carpenter's interest as the Associate Member to fill the open position on the Planning Board until the next election. (See Correspondence 198 & 198a).**

Moved by Mr. Coehlo, seconded by Ms. Houle to open the joint meeting between the Planning Board and the Board of Selectmen at 6:00 p.m.

Mr. Coehlo introduced the Planning Board as himself, Ms. Houle, Mr. Phoenix present.

Mr. Coehlo thanked Mr. Quiterio for his service on the Planning Board and explained to the Board of Selectmen that Mr. Carpenter would be a great asset to the Planning Board as an Associate Member.

Mr. Goncalves asked why Mr. Carpenter wants to be a part of the Planning Board?

Mr. Carpenter stated that he wants to give back to the community. He was on the Senior Center Committee. He is also currently on the Housing Committee as Vice Chairman.

Mr. Goncalves asked if is cleared by ethics regarding the Housing Committee?

Mr. Carpenter stated that he has been cleared by ethics.

Mr. Goncalves thanked Mr. Carpenter for being involved and stated that we need more volunteers like him.

Ms. Rooney introduced herself and stated that she has been on the Ludlow CARES Coalition for over 10 years now. This will be the 10<sup>th</sup> year of Red Ribbon Week. They are still an all-volunteer coalition and meet on the first Wednesday of every month. She asked the other members to introduce themselves.

Ms. Roy introduced herself as a former educator in town and she has been with Ludlow CARES since the beginning.

Mr. Bovee introduced himself as the Vice President of CARES, he is also a resident with two children currently in the school system and is a recovering alcoholic.

Chief Valadas introduced himself and is very happy to support the Ludlow CARES.

Ms. Rooney stated that Red Ribbon Week is October 23<sup>rd</sup> – 30<sup>th</sup> and stated that there has been an increase in Red Ribbon Week in surrounding communities. The posters will be out in the schools and community. The theme this year is 'Drug Free Looks Like Me'. The Ludlow CARES Coalition fundraises once a year and this year they raised over \$20,000. There was no fundraising in 2020 so this was a great fundraising year. Lollipops and bracelets will be available for the community from Ludlow CARES. These gadgets help start the conversation with younger children as well. Ms. Rooney also reminded everyone that they will be having their annual walk to remember in conjunction with the Michael J. Dias Foundation and that will take place on Sunday, October 24<sup>th</sup>. It will be held at the Boys and Girls Club. You can request a luminary to remember someone that has passed or is currently struggling with addiction and these will line the walk to remember event. On Thursday, October 28<sup>th</sup> the Board of Health, CARES and Tapestry Health will have Narcan training at Our Lady of Fatima Parish at 7 p.m. Ribbons will be hung around town on the 23<sup>rd</sup>. The soccer team helps get this done. This helps families begin the conversation regarding drug abuse.

Ms. Roy stated that a lot of different members of the community are involved in Ludlow CARES, such as the soccer team, the Police Department, the Board of Selectmen, the schools, etc. Literature is passed out to the schools to distribute to the kids. This year they are focusing on social media as well. Ludlow CARES now asks the schools and the boys and girls club for different ideas and what to focus on each year. The Red Ribbons can be a great conversation starter with young children.

Mr. Bovee explained that CARES helps parents discuss addiction with their children and lets addicts know that they are not alone in their struggle with addiction. You don't want people to suffer in silence. He appreciates the support the town lends to CARES also.

Chief Valadas explained that the drug take back will be October 23<sup>rd</sup> with Officer Dobek and Officer Mayou. There will be a tent in front of the main garage bay. The Police will partner up with the DA. However, they cannot take needles or large amounts of liquids. There will be officers at the walk as well.

Ms. Rooney stated that there has been a rise in drug overdoses since the pandemic began. Keeping the line of communication with your family is the key. She reminded everyone that the Michael J. Dias has a support group on the 2<sup>nd</sup> and 4<sup>th</sup> Tuesday of every month at 6 p.m. at the Lusitano Stadium in the offices on the left as you go in. CARES is also to improve the mental health of the community.

Mr. Goncalves extends his gratitude to CARES for helping people in need and for educating our children about drug addiction.

Mr. DeBarge stated that he loves the Ludlow community and feels that community involvement is key to keep this going.

Mr. Silva supports all efforts of the CARES program.

Ms. Rooney thanks the Board of Selectmen for being involved and explained that the community needs to keep pushing ahead and having these discussions.

Mr. Goncalves read the proclamation from the CARES program regarding the Red Ribbon Week for 2021.


**CLOSING COMMENTS**

Mr. Silva spoke to the Board of Health and the COVID numbers have come down considerably but does not want the residents to get lax. Try to isolate if you have symptoms and try to keep the numbers down in order to avoid a mask mandate or shut down. Stay vigilant. Keep safe.

Mr. DeBarge stated that the Civil War Monument repairs are progressing well. If residents would like to stop by to see the work being done, please be cognizant of where your stop and let the workers continue their work. Mr. DeBarge commented that he feels that residents should be able to make comments at any meetings within the town. After going to a school committee meeting recently, he noticed that comment section was moved to the beginning of the meeting and then the committee does not comment on any of the questions or allow for further questions. In order to comment on it, you would have to write everything down from that particular meeting and then attend the next meeting to ask your questions. He thinks that this is despicable and parents should be allowed to ask questions regardless of the content.

Mr. Goncalves wanted remind residents to be cautious being around others who are sick and to be safe. He also stated that there are now scams with College Scholarships. Do not give out personal information to these scholarships unless you have researched everything beforehand.
