Board to revisit request from Faith Community Chapen regarding snow removal and East Street School parking (Tabled from July 11, 2023)

Mr. Strange: The Faith Community Chapel is located across from East Street School and Pastor Lisa from the Chapel approached the Town about potentially having the DPW plow their parking lots during snow events with the thought being there are parents during drop off and pick up who park in the parking lot creating an informal quid pro quo, the Chapel allowing parents to park there and the Chapel asking the Town to help them out with snow events. The Board discussed it at the last meeting and you all requested us to go back to Town Counsel to see if this was possible. We spoke with Town Counsel and they said it is possible. They wrote up an agreement, which was sent to the church. The church wanted to get into some of the gritty details. We told them that the Board hasn't voted on anything yet. So, we paused there and put this back on the agenda for the Board's decision whether or not to move forward with an agreement or tell them we're not interested.

Mr. Gennette: Was our agreement sent to them?

Mr. Strange: Yes.

Mr. Gennette: Are they making modifications to the agreement?

Mr. Strange: Yes. They're lawyering. They're squabbling over language. Ultimately, if the Board chooses to do this I have no doubt we're 90% there. One of the outstanding questions was if there's a snowstorm on a Sunday and it's not during school will the DPW come and plow them out. Some of that stuff I don't have the authority, but also the Board hasn't decided where they want to go with it yet.

Mr. Gennette: I think they still plow the school even if...

Mr. Strange: They plow the school but they wanted them to plow the chapel at the same time.

Mr. Silva: It's a big problem over there on East Street, as we all know. Now it becomes a safety issue. Maybe that will alleviate some of the traffic. Quite honestly, I don't see the big ramifications. The liability and all of that is all taken care of to me it seems like it's fine for them to do it on a Sunday and keep the parking lot plowed. It's not going to cost the Town a heck of a lot of money. Maybe half an hour's work for one of the drivers. I don't see an issue with it if the attorneys don't see an issue with it.

Mr. Strange: Depending on what the Board decides, if you decide to go forward with it we'll have the attorneys iron out some of the stuff and if there's outstanding issues we'll bring it back to the Board so you all can decide on some of the stuff. There's some liability language in there, stuff like that. Some details need to get hashed out.

Mr. Goncalves: Along the lines of what Mr. Silva said, it seems like there's an issue at all our schools. The high school, Harris Brook & certainly East Street. Anytime we can get any type of assistance or break to take cars off the main drag and make it a little bit safer with less commotion I'm definitely all in. If it's a weekend storm and it's got to be clean for Monday, why wouldn't they go in and clean it as normal course. If the attorneys can iron out everything on their end, I'm in.

Mr. Rosenblum: The only sticking point for me is to make sure the language the attorney's put in there keep it closed ended so we don't open up Pandora's Box of everywhere in Town saying we did this for the schools. I have the faith in the attorneys to do that. I don't have a problem with this at all. We've probably all had kids go there. My kids went there, understanding how it is going through that area and trying to cross the street. 20 mph is not happening all the time. I don't have a problem with it. That's my only concern. I hope we don't get into a situation where we start getting other places asking for that.

Mr. Gennette: As far as the legalese, I'm fine with it too.

Mr. Strange: In the course of these negotiations between the attorneys, there's questions that come up that are really more policy than legal, how would you like us to handle that?

Mr. Gennette: We've already presented our paperwork to them? So, whatever those questions come back to, we obviously have to get those answered. Policy questions have to come before the Board.

Mr. Strange: I propose we will ask the attorneys to hammer out as much as they can and bring any policy questions along with a final draft for you guys to make a decision and we go back to the attorneys. We'll have to go back a 3rd time I guess.

Mr. Goncalves: Are we in agreement that whether it's a weekend or school vacation week we get it cleaned? I can see what's happening is they're going to eliminate that contract they have for cleaning the parking lot. They're going to put it on us and we're agreeing to do that. I would say if it comes down to that we should clean the snow every time.

Mr. Gennette: My only concern is when people don't get it done as fast as they would want it they would have to get the parking lot done when the DPW can do it in their schedule, which may not be 5:30 in the morning before everybody has to show up for work.

Mr. Silva: I'm sure they'll do it when they do East Street.

Mr. Gennette: I think we're all kind of trying to make concessions here.

Mr. Goncalves: That particular church is going to be as important to us as the parking lot itself of East Street. It probably handles just as many cars or the influx. The traffic pattern of getting it off the main drag, especially with snow on the ground, is important.

It's going to be a few extra passes between the 2 streets. It's not a parking lot. It's actually going to be a cut through more than a parking lot.

Mr. Gennette: What about snow piles?

Mr. Goncalves: They have plenty of room there.

Mr. Gennette: Mr. Vestal, do you have anything?

Mr. Vestal: Is this an agreement or agreement in theory?

Mr. Rosenblum: The only sticking point for me is to make sure the language the attorney's put in there keep it closed ended so we don't open up Pandora's Box of everywhere in Town saying we did this for the schools. I have the faith in the attorneys to do that. I don't have a problem with this at all. We've probably all had kids go there. Mr. Rosenblum: We've already received funding for it.

Mr. Gennette: I can read her description of what's going on. We were going back & forth with Chairperson for the Board of Health, Kelly Lamas, and she answered some of the questions I put out to her. I requested her to come visit. She asked what it was about. I posed some questions to her and these were the answers she sent. The Board was interested in the project overall and would like specifics about any new positions being added. Any impacts any new positions may have on the Town and if the Board of Health will be submitting anything related to the Shared Services Grant up to the Town Meeting via warrant articles. She responded, we're currently still in a bit of a waiting game from the grant from the DPH and other towns. My thought is to wait until the new year for a more formal update at a meeting. In the meantime, here are some high-level details about the public health excellence shared services grant. Public Health Excellence Shared Services Grant 3-year cycle with opportunity for 2-year additional cycles that will total 9 years. DPH's goal is to build capacity within Health Departments participating in the Shared Services municipalities and to create a sustainability model under DPH guidance post grant cycles. This is part of a larger statewide effort under the SAPHE 2.0 act. Under this grant, we created the Mill Town's Public Health Coalition made up of 4 municipalities, Ludlow – fiscal agent, Palmer, Warren & West Brookfield. DPH approved \$449,000 for the Mill Town Public Health Coalition admin support for FY24. Since Ludlow is the fiscal agent, DPH cannot exceed 15% of the budget to go to management, supervision and stipend to local health director working beyond regular hours to support shared services arrangement. As of 10/10/2023, we have currently received \$147,500. Since Ludlow is the fiscal agent, yesterday 11/13/2023 the Town Accountant created the Mill Town Public Health Grant budget that will hold all shared service funds dispersed from DPH. These funds are to only be used for grant efforts and per DPH prohibited costs include capital expenses under any circumstances and supplementing existing municipal funding for the public health services. The coalition was approved by DPH to hire 4 shared positions. Shared positions will be formally hired under Ludlow, as Ludlow is the fiscal agent. The approved DPH Shared Services Grant budget will pay for all fringe and benefits that will be provided by the Town of Ludlow. Positions will report directly to Paulina. DPH has approved the 4 below positions that will be shared between all 4 municipalities. One full-time employee shared services coordinator, one full-time employee shared environmental health inspector, one full-time shared social worker, one full-time shared health...half a nurse. Governance: there is an inter-municipal agreement already approved by Ludlow's Town Counsel that must be signed by all participating municipalities. We're still waiting on the other 3 towns to sign. Each Board of Health will designate a representative, which has already been done. I am the representative for Ludlow. The Governance Board will meet quarterly and will make decisions about cross-jurisdictional policies and personnel, including all positions, descriptions and hiring, operations and finances. Each municipality shall retain its Board of Health legal authority unless a municipality votes to delegate part or all of its authority to the Governance body and the Governance Board votes to accept it. Board of Health must approve agreements to delegate their legal authority. No anticipated articles or warrants for Town Meeting. Thanks. Kelly. Marc, one question. How does that work? We're going to pay them and get reimbursed by the State?

Mr. Strange: It's not reimbursable. They give us the money. As Kelly was saying, Shawn set up accounts for all these different functions that are going to be effectuated through the grant. Those monies are just going to be paid for out of those funds.

Mr. Goncalves: All fringe and all benefits will come out of that money. It's not going to cost us anything?

Mr. Strange: With respect to Capital, the Library submitted a request for \$214,000ish for the window restoration project. For the Board's recollection, Capital 2 years ago approved \$16,000. That wasn't enough. Library had to come back for another \$46 or so. There's been \$62,000 that were approved through Capital for this project; however, that was before an architect went out and took a look at the windows. They are full of asbestos. They're historical. That elevated the project to \$281. That was considered last night. When the Library submitted their capital request along with the library restoration, they also submitted a few other smaller items. Those smaller items did not rise to the level that would qualify them as capital so we suggested maybe the Board would consider funding those repairs through the Building Infrastructure Fund, which is what's in front of you tonight.

Mr. Silva: A couple meetings ago we did have a gentleman here to discuss some of the issues going on there. I was in the library for a meeting and noticed some of the things they're talking about. Some of the peeling paint on the walls or if some of the issues have been fixed or not.

Ms. Collette: It's beyond peeling paint. Plaster is pulling away. There is about 30 cracks in that room alone. We had the roof inspected. There were some minor repairs done for that. As we all know everything starts from the roof down. We didn't know what that entailed. If it was the roof or both. It's peeling away from the walls and we don't know why. Because it has to be a restoration project we're starting with the windows. We know the roof has been repaired. The windows, if you recall when the former Director and I came to a Board of Selectmen meeting, we had to take the lowest bid and that was the \$16,000 bid. After that they informed us that the bid at \$16,000 was wrong. They didn't include many things that needed to be done, which explained a lot of the disparity between the other bids we got. We were getting bids in the \$80,000. Everyone that came

out to look at the windows said, one gentleman said, while it was not the worst he had ever seen, they definitely needed to be done within a year or so, and that was 2 years ago. I don't know if you had a chance to look at the condition of the windows...

Mr. Silva: Not formally. I didn't inspect the windows but just by being there you could see. It was pointed out.

Ms. Collette: We came to Capital, they gave us the additional money, like Marc stated, and then we were told by Leslie and Lori Belanger that we needed more inspections. That was done and that was when the asbestos was done. The testing came back and the paint around the windows is full of asbestos. We all know that the minute that word is mentioned your project price can quadruple and that's where we're at right now. That is the reason for the large expense for that.

Mr. Silva: We have an exceptional library building there. It's probably historic so \$16,000-\$17,000, I don't see that we should have an issue getting some of those issues repaired.

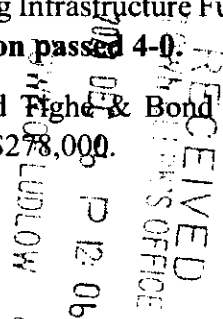

They don't want dogs to come up to them and sniff them and get all nervous. I suggest people be considerate and maybe take a look at putting a couple signs up there.


