Executive Session:

Observer was asked to leave and Session commenced. We are meeting in Executive Session in order to address a situation created by a social club that meets weekly at the Ludlow Senior Center and has gone out of control. Director has met with them several times and offered help in trying to resolve any problem(s). Well intentioned offers were not well received and interpreted as intrusive criticism. The club's membership dwindles, meetings are disruptive and members are unsure of club's present financial status. Further, the club has failed to comply with Article VI which states the club will pay \$50.00 per month to the Friends of the Ludlow Senior Center for use of facility and copier. Because of the continuing discourse and seemingly poor compliance of rules and regulations, the club was advised to see other premises in which to meet. This was met with unwarranted charge of elder abuse filed at Ludlow Police Dept against the Director and maligning said Director's character and reputation. Council then voted the town of Ludlow develop a policy of use of rental space. The vote is on the table and Session ended and regular meeting resumed.
