First Order of Business: The Pledge of Allegiance

A question was asked at the Wednesday night meeting re: Elections Department, questioning the full-time elections position and overtime. Mr. Gregoire stated that the Other Temporary Salary relates to the extra election, Primary and Regular Election. Police Officers, early voting, extra help if more space is needed. Regular Overtime relates to the office staff, work on election day and overtime for that day.

That amount is a \$107,075 adjustment

There was a State Grant that offset the budget so they utilized the grant in that way. It was a matching type grant. It was from MEMA. It was recommended to use the full funding of \$18,000 and then the Town would get back a ½ reimbursement.

Mr. Gregoire would want to vote on this because of the time line of Town Meeting. The goal is to complete the recommendations by next week. Budgets could certainly be revisited. Mr. Alves things that it would be good to have the

summer help and hopefully that work force will be there. He was just curious, but will not hold him back from voting.

That is about a \$50,000 value for the closure of the pond. There is also an adjustment down for the before and after School Program because of the restrictions. That is also a cut and the amount is reflected in the Level 3 column. Mr. Alves asked about the plans for the Summer Camp and how it's reflected in the budget? Mr. Gregoire stated that based on the response from the Commission, their continuing to plan to open the Summer Camp and will abide by the guidelines that will be provided. There are no guidelines set to date.

Mr. Alves questioned a few line items and would like more information. They are school supply line items. One in particular is a 300% increase. Went from \$4,000 to \$16,000 He would like to know the reasoning behind it. The other one is in the Athletic Department, that jumped from \$11,000 to \$43,000. He would like background on that also. Ms. Downing said that the committee can investigate and ask questions, but the committee has no prevue over the line items in the budget. The school is autonomous as far as the line items. Mr. Gregoire said that the Superintendent was open to provide information to the committee as to why there were changes. Their cutting their service budget so it might be a matter of moving money in line items to address things that are needed in the year. They had to purchase new books etc. but their holding off on those things, so they made substantial cuts and it reflects at the bottom line. Ms. Boyea states that if Mr. Alves would like clarification, the committee could take a vote on their budget and he could still get his clarification. We can't tell the school department where to spend their money. If he has questions, he should get the answers. He would feel more comfortable before voting, but if the committee wants to vote that's fine and he could get his answers afterwards.

Ms. Collins is working on the changes. Mr. Gregoire would feel comfortable having more time to look at the budget with explanations. Mr. Alves would like to hold off voting until Ms. Collins has more changes. Ms. Villano said that she and the Town Accountant reviewed the whole budget before it was sent to the Golf Commission. There was a conference call to discuss some issue that they were having. Ms. Villano suggested at that time that the Town Accountant go over the budget with the full commission. At this point the committee should wait to vote and have Ms. Collins review the Budget Meeting of the Finance Committee dated May 28, 2020

Mr. Gregoire informed the committee that the next regular meeting will be held on June 17, 2020. Everyone received the draft Articles. He asked that we continue to review the Articles. If there needs to be a review meeting, they can be scheduled on June 3rd and June 10th. End of Year Transfers will be reviewed in a few weeks. The meetings will begin at 6:00 p.m.

Ms. Villano gave an update re: Town Meeting

Ms. Villano said they have been advised to rearrange the process of the Warrants. Most of the Articles will be taken out of the Annual Warrant and placed in the Special Warrant. The thought process for this move is to open the Annual Warrant, vote on those Articles that are specific to FY'21 vote on them and dissolve the Annual Town Meeting. The specific items for FY'21 have to be voted on before the end of the fiscal year which is July 1st. The Special Town Meeting Warrant will be opened immediately after to take up the remaining Articles. If need be the Special can be continued to another day if time runs to late. The second decision that was made was to hold the Town Meeting in the auditorium of the High School. Based on the fact that we are a Precinct Representative Town Meeting government, the most voters that can be in the auditorium is about 114 people. The Town Clerk, Ms. Villano and the Building Commissioner toured the High School and Mr. Larivee assured them that if everyone were to show up, they would still be able to have the 6 ft. distancing within the auditorium. This could be subject to change. People will have assigned seating and they will be spread out throughout the whole auditorium in order to accommodate the 6 ft. social distancing. There will be bright yellow stickers and numbers on every seat where somebody needs to sit. Ms. Downing asked about wearing masks. The people will be required to wear masks. All committee members will be permitted to attend, she's not sure if all of them will be able to sit on the stage. They will open the curtains and use the entire stage to hold the Selectmen, Town Counsel, Moderator, Town Clerk and as many of the Finance Committee members that they can. The other thought was to have the committee members sit along the front of the stage in the audience. Ms. Tokarz asked when the Warrants will be available, when the Town Clerk has to mail out the packets of information and if the recommendations can be available at Town Meeting. Ms. Villano said that there will be a draft budget presented to the Precinct Members in the mailing packet. Once the Finance Committee make their recommendations, she will have a second mailing with the overflow information to send to each of the precinct members. She doesn't think that paper information should be allowed on the stage as in the past. Mr. Gregoire said that the committee can finish making recommendations at the next meeting in time to do a second mailing prior to Town Meeting. Ms. Villano is also working with the Board of Health to draft a protocol plan and the information will be sent out in the packets. They want to ensure the comfort of the precinct members that will sitting down to vote. Gloves, hand sanitizers etc. are some of the items

mentioned. Ms. Villano said if there are changes in the next few weeks, she doesn't know what will happen. There is legislation talk about changing the quorums of Town Meeting, but pertain more to communities that have an Open Town Meeting where every voted has the right to attend. We have a representative Town Meeting, which is more restricted. Mr. Gregoire appreciates the updates and adjustments that have been made to accommodate Town Meeting.
