Finance Committee budget meeting held on Wednesday, ppr FED8, 2021, beginning at 6:00 p.m. in the Selectmen's Conference Room, Town Hall.

Ms. Villano was also in attendance.

First Order of Business: The Pledge of Allegiance

The committee met with the DPW Chairman Steve Santos and James Goodreau to discuss a few of their Articles for Town Meeting.

Article 12: To see if the Town will vote to transfer an amount from Sewer Enterprise Account Retained Earnings and/or transfer the remaining balances from the following Sewer Division Capital Improvements articles: Article 22 of the May 9, 2016 Annual Town Meeting; Article 2 of the November 6, 2017 Special Town Meeting; and Article 9 of the May 13, 2019 Annual Town Meeting and/or borrow by the issuance of bonds or notes such sums of money as may be necessary for the Sewer Division Capital Improvements beginning July 1, 2021.

Mr. Santos explained that there were many Articles in the past that were not totally expended. They transferred monies from those Articles into one Article, titled Engineering and Construction. Money can be expended for both projects without having to create separate Articles. There is a job that is being bid on for after July 1st. There is \$300,000 being transferred into that one Article and the project will cost \$453,000. He doesn't know if those funds will be enough to cover the job. The project entails three different streets. Tower Road is the preliminary job, Motyka Street from Marie Street to West Street is another project and option 3 is Grimard Street. The next section to be done is West Orchard, West Belmont, Fairview, the streets between Cady Street and the turnpike, towards West Street Park. Those streets will be tied in to the manhole created from the first project. The maximum out of Retained Earnings that can be transferred is \$307,456 in order to maintain 20% of the operating budget. If there is \$720,000 all project will be completed. If not, the projects will be done in stages.

Jim Goodreau gave an explanation of the completed projects and other projects that show on the spreadsheet. Ms. Downing and Mr. Goodreau discussed the cost for the projects and what money is in the Articles.

Articles 13 and Article 16 - No action being taken

Article 14: To see if the Town will vote to appropriate State Chapter 90 Highway Aid Funds for engineering, construction, reconstruction and/or repairs to Town roads and bridges and authorize

the Board of Selectmen, if necessary, to borrow in anticipation of the receipt of such State Aid; pass any vote or take any action relative thereto. RECEIVED

This is the Chapter 90 Article. They will be receiving \$694,010 from the State, for Highway Aid. 2022 FEB -8 P 12: 28

Article 15: To see if the Town will vote to authorize the Board of Public Works to enter into a contract with the Massachusetts Department of Transportation for the construction and maintenance of public roads for the ensuing years; pass any vote or take any action relative thereto.

This Article is needed for the DPW to spend the Chapter 90 money received from the State.

Article 16: To see if the Town will vote to raise and appropriate and/or transfer a sum of money to establish a Fiscal Year 2022 budget for the Department of Public Works Enterprise Fund for the Closure of the Landfill; pass any vote or take any action relative thereto.

No action will be taken. The money is now in their budget for the closing of the Landfill. The Article will be withdrawn.

Article 8: To Change the Senior Citizen Property Abatement Program by changing the dollar amount from \$500 to \$750 changing the Federal minimum wage to follow the MA minimum wage. The minimum wage will go up to \$13.50. Ms. Villano explained that the program with 75 people is \$37,500 in abatements. If it is increased to \$750 per person it will increase to \$56,250 in abatements. The threshold for hours will change from 68 hours to 56 hours. Same number of slots. The people that were chosen last year but couldn't work because of COVID, will work this year and finish their program. Ms. Villano explained the lottery system and waiting list. The program varies from town to town.

Mr. Alves said that there will be a loss of labor hours. He asked if there is a need for those lost hours. Ms. Villano said that they sometimes struggle to find work for people to do. The Senior Center rely heavily on their slots. The library has a list of jobs as does the Golf Course. Candidates have to be 62 years of age or older and own your home for ten years. One member per family can work the program.

The vote will be taken prior to Town Meeting in case more bills are added.

Article 2: Transfer from Free Cash money to fund the Overtime expenses incurred by the Police Department. At this time the amount is \$100,000. It could increase.

The vote will be taken prior to Town Meeting in case the amount changes.

Article 3: Transfer money from Free Cash to cover the deficit in the DPW Trash Fees. Bills have not been sent out to date. Ms. Collins spoke with DLS. If there is enough money in other funds, they won't need this Article. Unanticipated free holiday from Fringe Benefits from this fiscal year, should be enough to cover any costs. It's her understanding that within the next few weeks, the bills will go out to the residents and they have 30 days to pay it. No action will be taken on this Article.

Mr. Alves asked what the volume of fixed assets are under \$10,000. Ms. Villano doesn't have the exact number. There is not a lot under \$10,000, most of the assets are well beyond that amount. For insurance purposes there is a listing, the Town Accountant would have that information.

The first three years are under warranty from 3 to 9 years the amount is \$81,714.19. Mr. Moskal asked why 10 years. Ms. Villano answered that it's the life expectancy of the equipment.

Mr. Gregoire said that everyone should have received the background that the Planner had provided. The Planning Board recommended approval of the Article 5-0 at their February 11th Public Hearing and there were no abutters that called in to disapprove of the Article. The ownership is the only thing that changed in the Article, when it was presented last year. There was a process that just closed.

Businesses could give out paper bags. Mr. Alves said the exact Article was brought up at Town Meeting and voted down. He said that in certain studies, there is no real reduction in the plastic bag. He doesn't see plastic bags flying around the Town. Certain areas of the country stores will

charge for the bags and the towns will get a percentage. Ms. Downing said that she saw a program on recycling and how people save their water bottles cans de The percentage that gets recycled due to different laws in different states is 3-5% which is extremely low. When a bylaw is put in effect like this one, it tends to make the residents relax more She doesn't think that the regulations will change the patterns of habits. Mr. Alverallie poke about single use. Bags are being reused. It was defeated last year, he doesn't know why thex are bringing it back this year. Mr. Gregoire said plastic bags are going by the wayside. Paper bags are more prevalent. He sees a lot of trash from plastic bags and there is something that can be done to reduce them. Ms. Cavallo asked if the Town does pass this bylaw, what will happen to individuals passing out supplements in Town from the newspaper. Mr. Gregoire said those projects would have to stop. Ms. Parker said that she saw a program on television and stated that most of the plastic comes from commercial fishing boats. If we can do something to ban the bags, she feels it's a step forward in the right direction, stopping all the waste. Ms. Boyea said plastic bags are used in the house, but it's not being allowed to be littered. There are communities that ban the single use bags but still give out the heavier handled plastic bags. Ms. Tokarz read the Article stating what types of bags are permissible and what bags are not.

Moved by Ms. Downing, seconded by Mr. Alves to disapprove Article 3 budget at \$74,348,111 and instead approve the budget with the Finance Committee recommended amendments for the following departments: Human Resources, \$130,037; Police Department, \$3,931,042; Department of Public Works, \$3,394,402; Recreation Commission, \$337,235.
