 - A. Michelle Goncalves welcomed our two guests Audrey and Ebony, graduates of The Young Women's Initiative. We invited them to discuss their experience in this program and any other issues they are facing as young women.
 - B. Audrey-sophomore at UMass Boston. International relations major with minors in public policy and theatre. Joined YWI in the first cohort in 2017. They created a mini-grant program for nonprofits that benefit women and girls. They had to do a task force and do research to determine what grantees should be approved and had to research women leadership.
 - C. Issues important to Audrey, women's reproductive rights and education reform. Believes English and History classes need to be reformed to create more diversity and inclusion. Environmental reform.
 - D. Ebony-joined YWI last year. Researched it before she applied and was very surprised to find a program run by women for women. Met with speakers who all had different roles in society and different roles of power in society.
 - E. Women's health is very important to Ebony and the lack of information in high school about it so this was her task force to research. Concerned about all the laws in place about women's bodies and the lack of laws governing a man's.
 - F. Commission members then asked questions regarding the information provided and about what they are doing now. Learned about how they heard about the program and got involved and how we can get the word out for more young girls and women to apply. Lizzy asked for their email addresses to reach out to them in the future.
