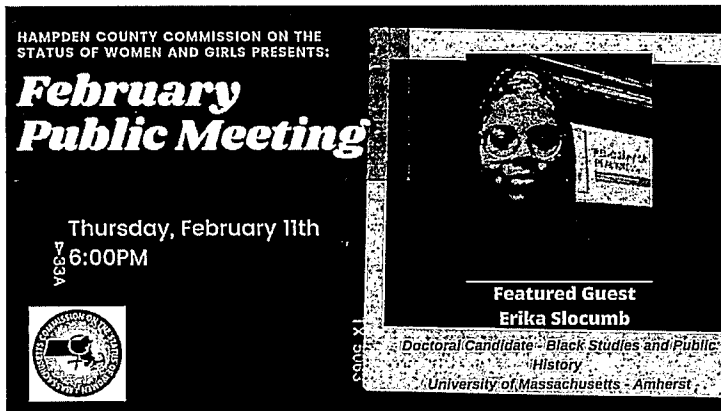

X. Adjournment- Gabrielle called to adjourn at 8:04 pm, Pattie seconded, so moved and all in favor.

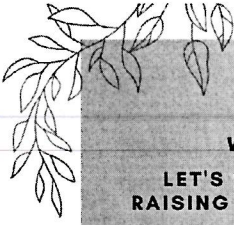
