B. Ludlow Housing Authority Annual Plan hearing:

Plan was reviewed and questions answered. Discussion ensued about items that Board Members and tenants would like to see added into the five-year CIP plan.

5. Bathroom Vanities Wilson Street 667-2 and 667-4.
6. Bathroom Vanities 39 Chestnut Street.
7. Kitchen cabinets at John Thompson Manor (6) units
