1. Call to Order

VI. Guest Members representing Minechoag pond issues

- a. Bill Simmonds presented pictures of Minechoag pond condition (very weedy and "mucky") along with a picture of storm run-off into the pond.
- b. There are two locations of storm run-off that feeds directly into the pond (763 East Street and 361 Chapin Street) which allows for road debris, salt, oil and trash to feed directly into the pond.
- c. Judy will contact Conservation Committee to inquire if they are aware of this situation.
- d. Other guests are concerned with the quality of the water and agreed the pond is not usable in the hot summer months. There is a great concern for any wildlife in and around the pond.
- e. This pond has been identified in the Natural Heritage database which indicates an even greater need to address the issues for this pond.
