
OPEN DISCUSSION:

Vote: 6-0 all in favor


Lines need to be repainted at Center Street & Miller Street intersection

Mr. Smolinski made a motion, seconded by Mr. Coelho, to adjourn at 5:51 p.m. Vote: 6-0 all in favor






