


OPEN DISCUSSION

Ms. Graf requested the barrels be replaced on East Street to help with the line-of-sight problem in front of the nail salon. DPW will put them back up temporarily.


Motion made by Mr. Coelho to adjourn the meeting at 5:49 p.m. **Mr. Tomas second. All in favor. Motion passed 6-0.**
