From our Town Clerk's Office: Our Annual Town Election is Monday, June 1, 2020. The polls will be open from 10:00 a.m. to 8:00 p.m. For this election, early voting by <u>mail only</u> is available for any qualified voter for those choosing <u>not</u> to go to the polls on Election Day. Applications for an early or absentee ballot are located on the Town of Ludlow website. The deadline to apply for the ballots is 12:00 p.m. on Friday, May 29, 2020. Download the application or written request and scan to <u>clerk@ludlow.ma.us</u> or mail to Town Hall. You can also drop them off at the Town Hall Collector's mailbox located in the back of the Town Hall.

Ludlow Dog License Reminder: The Town Clerk is extending the Dog Licensing period (which expired on March 31, 2020) to August 31, 2020 due to the COVID-19 pandemic. This extension will be without incurring any late fee. You must have a valid rabies certificate to renew or obtain a new license. Neutered/spayed dogs are \$15.00; dogs that are not are \$20.00. If needed, a form is available on the Town of Ludlow website. Please include a self-addressed stamped envelope, copy of a valid rabies certificate, along with a check payable to the Town of Ludlow. From our Veteran's Service Officer: Sadly, due to the global COVID-19 pandemic and the current Governors policy on social gatherings and physical distancing, The Town will not be holding its traditional Memorial Day Parade. As a town we will always continue to honor the brave men and women who gave themselves for our freedoms. From our Department of Public Works: The Board of Public Works has voted to return to normal hours of operation at the Transfer Station and Compost Facility, which are Wednesday thru Saturday 8:00 a.m. to 3:00 p.m. Last year's Transfer Station Permits will be honored. If your do not have a permit, the attendant will confirm that your vehicle is registered in Ludlow. Bulk items must be paid by <u>check only</u>. Please remember to wear a mask and maintain proper distancing when using the facilities.
